# Rainier Hunting Retriever Club Meeting Agenda

September 7, 2021

Attendance; Doug Gallucci, Sue Meyring, Jean Fowler, Liz Gibson, Jim Olson, Eric Marek, Dianne Clark, Bill Woll, Susan Bell

President Betsy was unable to attend the meeting so Vice President, Doug Gallucci called the meeting to order at 6 PM.

Minutes from the August meeting were reviewed and approved.

Treasury Report (Sue Meyring) – RHRC Account: \$14,210.98 Tri-Club Account: \$607.50.

Fall Hunt Test:

Winger/Holding Blind Raffle: \$1,102.20. The raffle was well supported thanks to promotion by Diane Clark and Sue Meyring. This money will go toward the purchase of an Automatic External Defibrillator (AED). It was recommended that we hold another raffle at our next HRT.

HRT Financials. Sue went over the income/expenses for the fall test. A discussion included credit card fees (high), motel fees for judges, lunch and worker costs. Major expenses were: Birds (\$3,713), Judges gifts/travel/food (\$1,788) and Workers (\$1,410). It was noted that our profit would not have paid for two flyers in each stake.

Income: \$14,433.41 Expenses: \$11,485.97 Balance: \$2,947.44

RHRC paid entire cost of the Stake First Aid Kits (thank you Katie Quarles for putting them together) and it was recommended that the Tri-Clubs be asked to contribute to their cost.

Other: \*Judge David McPherson purchased gas but donated the cost to RHRC (did not claim expense).

\*Ask PSLRA if they will split the cost of gas for the thunder guns (already purchased)

## Hunt Test Season DeBrief:

Liz had a lot of difficulty recruiting volunteers to help at our test. She continues to need help and recommendations on who to ask. This will be especially important in the spring of 2022.

There was a discussion regarding complaints made by workers regarding their treatment during the test. The concerns will be addressed by Betsy Reali and Bill Wohl.

Jean requests a list of people who might have test dogs as there was a complaint that the senior test dog was overqualified to run as a test dog (had a MH although run by a novice handler)

#### Committee Feedback:

\*Event Chair/Liz Gibson – Overall a successful Hunt Test.

\*Gun Captain & Ammo/Bill Woll – We have 3/5 case of 12 gage and 2 cases 200 gage ammo. Fred Drennan will be thanked in the next newsletter for his donation of a case of 12 gage #7 steel. We currently have sufficient ammo for our spring test but will need to purchase additional ammo for our fall test. We use about 3 cases of ammo/test. Discussion was tabled to our next meeting. #7 steel shot continues to be difficult to find.

\*Chief Marshall/Jean: There is a recommendation to purchase additional radios (TriClub item?). \*Test Logistics:

✓ Worker Contact List: Need continual updating.

✓ Dumpster, Honey Buckets: No dumpster was available for either RHRC or PSLRA tests. We need to plan something different for 2022. Perhaps connect with Will Hart to see what his suggestions might be. Liz Gibson will contact Will.

 $\checkmark$  Porta-potties: Additional station is needed in the back of the property. Hunt test participants may not use Hart's outbuilding potty. Ask Will if he can lock his bathrooms.

✓ Lunches: KUDOS to Sue & Jan! A big thank you to Randy Clark for the Judges Pizza dinner. There was a complaint that lunches were delivered too early and could not be kept cool. Do we need

coolers for the lunches?

✓ Fund Raising Raffle – Dianne & Sue – Gunners Up Winger and Holding Blind Raffle

Raffle tickets were sold at \$10.00 each - net proceeds were: \$1,102.20

Next steps – AED Purchase – Should the Tri Club share in the purchase of the AED?

 $\checkmark$  Photo orders: No report at this time. Gary Abbott took the photos – Nomad Retrievers. His website has information on how to access the photos he took at the fall test as well as the cost of purchasing the photos.
